Responsibilities and Refunds:

By signing contract, both parties agree to the exchange of the photographic services for the above mentioned photographic session, and the photographic product outlined in “Products and Services” for the payment set in “Total Due.”

The signatures also represent the photographer’s responsibility to produce said product and services in a timely manner which is considered to be no more than 30 days for finished images, an additional 30 days for prints, cards, and disk products, and 6 weeks for digital books and albums.

Wedding Photography Deposits are non-refundable. However, a full refund of all money paid by client will be in order only in the event of destruction of digital equipment through no fault of the photographer. Furthermore, the photographer will not be held in any liability in such an event.

Photographer may not be held in any liability to any cost incurred in any part of contracted wedding for any reason.

Acceptance of completed product serves as an approval of work and an agreement to pay stated amount.

Late and No-Show:

A late fee of \$20 will be applied to any photographic session for each 20 minutes from the scheduled shoot time that the client is not present or ready. After 40 minutes, the client will be considered a no show and will have to reschedule and pay an additional \$100 for an engagement or portrait session. Aimee Wheeler Photography is entitled to keep the full payment in the event of a no-show.

Ownership and Reproduction:

Aimee Wheeler maintains sole ownership of all images for which this contract applies and extends limited reproduction license to the named owner(s) of original disk only. Reproducing purchased professional prints or the digital negatives is a breach of contract. Additional disks of digital negatives may be purchased separately from Aimee Wheeler Photography. Signature of client below grants permission to Aimee Wheeler Photography to reproduce and utilize any images taken from the photo session about which this contract is written.

In the Case of the Unthinkable:

If the unthinkable occurs and the Aimee Wheeler is forced to be a no-show at your wedding (for example, car accident on the way to the wedding,) Aimee Wheeler Photography will make no effort to find a replacement, but will provide a 100% refund of all monies paid within one week of the ceremony date. In the case that the unthinkable should occur, it is wise for the bride and groom to depend on family and friends to provide candid and posed photos.
